## 2017 ENTRY and SHIPPING INSTRUCTIONS

The Washington Cup Competition is open to any and all spirits and liqueurs made in the U.S.

**Spirit Entry Form:** Complete one entry form for each product submitted. Please ensure that the entry form is fully filled out and lists the distillery name, product name, and spirit category, alcohol content, age statement and raw materials used to create the spirit (where applicable), as well as the residual sugar if the product is a liqueur. **Entry Fee:** There is a \$100 fee per entry. Please make checks payable to “Washington Cup Competition.” The check can be **MAILED WITH THE ENTRY FORMS** or **SEPARATELY** to **4510 W. 82<sup>nd</sup> Terrace, Prairie Village KS 66208**. *Please do not mail checks separately to Aixois.*
